#### **DESCRIPTION**

Disinfectant product in a wide-spectrum aqueous solution. Action against bacteria, Yeasts, moulds and algae.

#### **APPLICATION**

#### Recommended for

- Disinfection of surfaces contaminated by all types of micro-organisms, including fungi and algae.
- Protect against the growth of microorganisms.
- Treat preventively before applying paint or sprayed cork.
- Encapsulate the asbestos before applying the sprayed cork.

### **SURFACES**

• Concrete, cement, plaster, BA13, wood, painted surfaces, fiber cement, wood, galvanized steel, mortar, ceramic brick, etc.

## **INSTRUCTIONS**

- To protect surfaces from possible infections:
  - o The surface must be free of dirt.
  - Once cleaned, it is applied directly to the surface with roller, brush or spray. It
    is advisable to apply two crossed layers.
- To disinfect and clean surfaces:
  - You must clean the surface dirt of microorganisms, with soapy water or bleach.
  - Once clean apply the product with roller, brush or spray. It is advisable to apply two crossed layers.

#### RECOMMENDED CONSUMPTION

• 6 - 8 m²/L (approx. 0,15 L/m²)

### RECOMMENDATION OF USE

- Application temperature 5 35 °C.
- Repaint after 3 4 hours of drying.

### **STORAGE**

• Store in a cool place, at a temperature between 5 - 45°C, away from exposure to sunlight and frost. Up to 2 years from the date of manufacture, in the original container sealed and protected from moisture. One open use within 15 days.
